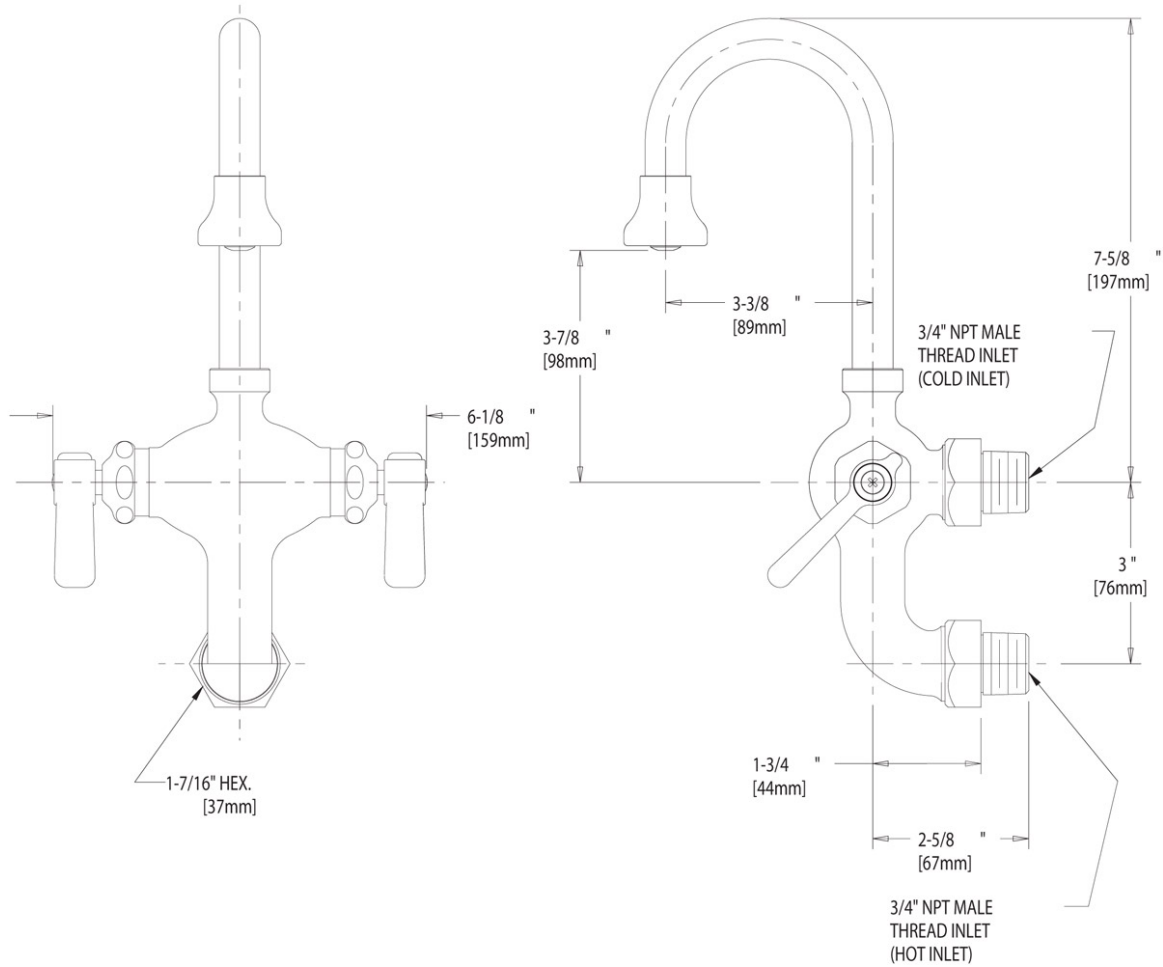

ECAST® construction with less than 0.25% lead content by weighted average. Secondary Control Valve: 3 3/8" Center to Center Rigid Gooseneck Spout.
